#### **Advocacy Training Transitioning to a Virtual Format**

Pam Boyce, the PWJMT member who has worked on the FCNL Advocacy Training publicity, reported on the changes necessary for the Training because of the postponement of the Michigan Conference. After discussion, the PWJMT agreed that the FCNL should go forward in a virtual format.

Pam **called us to celebrate the response to the registration for advocacy training.** There were seventyseven registrations through the conference web site. Pam informed us of the additional numbers she has through her offer to help people register. Pam has kept recruiters from community partners up-to-date and many are registering through these recruiters. Pam has also kept informed many people who had previously acknowledged their intent to attend. God is working in the hearts of many in our churches showing their desire to gain skills as we work together bringing justice through advocacy. Our advocacy discipleship will be God working through our "yes", transforming the structures and systems of the world back to God's intent. This is a long way of saying God is working in hearts showing the importance of advocacy.

Already over one hundred, and now the possibility of picking up additional attendees across the state who are interested in advocacy yet were not able to make the trip to Traverse City. Pam has committed to continue to be the point person informing the recruiters and attendees.
