The United Methodist North Central Jurisdiction recently held a virtual mission trip to the Oklahoma Indian Missionary Conference, <a href="http://www.umc-oimc.org/">http://www.umc-oimc.org/</a>. One of the participants with me on this virtual mission trip, Ruth Bowen a United Methodist participant from the North Central Texas Conference UMW put it this way in a follow-up email.

At the 2012 General Conference, the United Methodist Church held an Act of Repentance with Native Peoples (2016 Book of Resolutions). The act challenged every conference and local congregation to implement actions demonstrating a genuine attitude of repentance. Why? Because the UMC and its predecessor church bodies were, and **continue to be, complicit**, intended or not, in acts of discrimination, marginalization and violence against Native American communities.

What does our individual and collective repentance look like? It takes the form of advocacy and allyship. It means demonstrating our vows of prayer, presence, gifts, service and witness with Native American communities across America. ...It means educating ourselves and others with the truth about Native American history, thus the history of America. It means supporting efforts to decolonize education and remove harmful mascots from schools and sports.
